His Honour Judge Ivan Wong Principal Family Court Judge

His Honour Judge Ivan Wong obtained his LLB from the University of London, followed by a PCLL and a Master of Laws in Human Rights from the University of Hong Kong. He was admitted as a Solicitor in Hong Kong in 1991, and in England and Wales in 1993. He was called to the Bar in Hong Kong in 2002.

Judge Wong practiced privately from 1991 until his appointment as a Magistrate in 2009. He has served as a District Judge since 2017.

Mr. Eugene Yim Barrister-at-Law

Eugene Yim of Bernacchi Chamebrs has been practising as a barrister since 2002. Having a civil practice, his area of speciality is matrimonial and family law. Accredited in 2011, he also acts as mediator in all areas of civil law. He received advanced crossborder family mediation training with Mediation bei Internationalen Kindschaftskonflikten (MiKK), Berlin, Germany.

He has been appointed as a Deputy Judge in the District Court and the Family Court on an ad-hoc basis since 2018. He is currently a member of the Family Proceedings Court Users' Committee and a member of the Family Procedure Rules Committee.

He has been serving as the Honorary Secretary & Treasurer of the Hong Kong Bar Association since 2023. He is the Vice-Chairman of the Hong Kong Bar Association's Committee on Family Law.
